**I agree, that by renting a parking space from Student Parking.com to abide by the following:**

- A) No snow removal provided at any time.
- B) **No large capacity vehicles permitted at any time in any of the lots. No Suburbans, (4) door Tahoes, (4) door Jeep Wranglers or similar size vehicles, No Hummers, No Pickup trucks, No Vans, and No Toyota Land Cruisers. All of the above and more are subject to immediate tow.**
- C) Any patron using more than (1) space is subject to immediate tow. **You must keep all (4) wheels inside of your parking space lines.**
- D) Replacement parking permit stickers for any reason whatsoever are \$50 in advance. We use static cling stickers that you can transfer between vehicles. **You must keep up with it.**
- E) If you change vehicles for any reason, it is your responsibility to re-affix your sticker onto the new vehicle (inside lower left of driver's windshield) and **make sure to observe that no vehicles over 190 inches of overall length are allowed.**
- F) It is agreed that if any of the property is sold, Lessor shall have the absolute right to cancel the parking contract or any remaining period. The Lessee shall be refunded rent based upon the amount of time used (amount of time remaining on the parking lease).
- G) **You must be in a space by 9 AM on ASU home game days in order to use your parking permit for that day. NO EXCEPTION.**
- H) You can not sell your parking space without prior authorization and a \$100 change fee.

**VEHICLES EXCEEDING 190 INCHES IN OVERALL LENGTH WILL NOT BE ALLOWED**

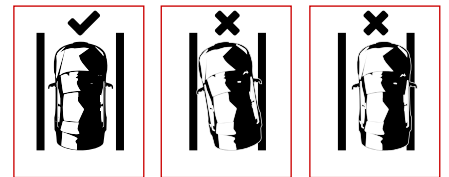
